STRAND PARKLANDS – EVENT CATEGORISATION

Category A events are defined as exclusive entry events, or events or activities where commerce is undertaken for private or corporate gain.

Category B events are defined as non-exclusive events (community based or otherwise) that have little or no income generating capacity and may possess commercial features such as advertising and/or promotions.

Category C events or activities are defined as events that can clearly be distinguished as a community event, targeted at a broad section of the community.

Category D events or activities are defined as non commercial events organised by Townsville City Council.

Irrigation Fee
